Welcome to Skøwire' ("Skøwire," "we" or "us") website, SKOWIRE.com (the "Website"). These terms and conditions (the "Conditions") apply to the orders placed by the customer ("you") in your capacity as a consumer for purposes outside of commercial or professional activities. By using the Websites and placing an order, you agree to be bound by these Conditions.

Please review the Conditions and make sure that you understand them before you make an order. We reserve the right to change these Conditions at any time without prior notice. The Conditions available on the Website at the time of your order, is the version applicable to your order.

### PLACING AN ORDER

In order to place an order you must be over 18 years of age and possess a valid credit or debit card issued by a bank acceptable to us.

Please note that all orders are subject to availability and that the inclusion of any products on the Website at a specific time does not mean that these products will be available at any time.

You can only place your order via the Website. Please make sure that all details you provide are true and correct. We will use the details provided to communicate with you about your order.

#### **OUR CONTRACT**

When you have placed an order, you will receive an e-mail confirming your order. Please note that this email will be an acknowledgement only and will not constitute acceptance of your order. A contract will be formed when we send you an e-mail confirming that the products have been dispatched. Only those products listed in the confirmation e-mail sent at the time of dispatch will be included in our contract. If we have already received payment for non-available products, we will refund the applicable amount using the same method used to make the payment.

## PRICING

The prices displayed on the Website do not include delivery costs, which are charged separately.

Please note that we ship to your destination on DDU (Delivery Duty Unpaid) basis[JL2] [RvA3]. This means that the prices displayed on the Website are exclusive of all taxes (included VAT) and duties. When your order reaches your country, you are responsible to pay any import duties, customs and local sales taxes. This applies for all deliveries outside of Switzerland. Unfortunately, we cannot predict what your charges may be. Please contact your local customs office for more information.
